Based on § 8 section 5 in combination with § 34 section 1 of the Law on higher education and cooperative state universities in Baden-Württemberg (State University Act - LHG), the Senate of the University of Applied Sciences Stuttgart has agreed on the following study and examination regulations on August 1^{st} 2012.

The approval by the Rector of the University took place on July 31st 2013.

§ 31a Master Programme International Project Management (Building, Real Estate & Infrastructure) - IPM (Fulltime)

(1) Standard period of study The standard period of study is 5 semester.

(2) Assignment of modules and language of instruction

The assignment of the modules for each semester and the associated examinations are shown in Table 1a. The courses and related examinations are usually conducted in English. The master thesis must be written in English. This thesis is presented in English in a 20-minute presentation.

(3) Specializations

Every student must choose one of the two specializations; this specialization cannot be changed throughout the study period. Only the electives that are taught in that area can be elected.

In table 1b and 1c the list of courses in each specialization can be found.

Specialization IBPM= International Building Project Management

Specialization IITM= International Infrastructure Technology& Management

(4) Deadlines

The processing time for the master's thesis is 18 weeks.

Pre-requisite for writing the master thesis is the successful completion of 55 credit points from Modules 1-8.

(5) Assignment of modules, kind of examination marks, final grade

In Table 1a, the module tests and the individual examinations are set.

The final grade will be calculated from the individual module marks, which are weighted according to the Credit Points set in Table 1a. The grade will be calculated from the individual teaching units that are weighted according to the Credit Points established in the curriculum.
